## WHAT PERSONAL DATA DO WE COLLECT AND WHY DO WE COLLECT IT?

**Contact forms and Cookies** We obtain information about you when you use our website(s) for example, when you complete the contact form, or send an email to the address in our menu, this provides us with personal data such as your name and email address. We collect information from the contact form, Mail Chimp subscription, Google Analytics and when people send us an email through the link in the menu. No sensitive data is collected or retained through our website. This may include personal data, such as name, email address, personal account preferences; transactional data, such as purchase information; and technical data, such as information about cookies. It is possible to switch off cookies by setting your browser preferences. Turning cookies off may result in a loss of functionality when using our website but can be done through the pop up which appears on entering the site. Google Analytics Analytics cookies are used for us to compile reports on our website and give us guidance on how we to improve. We collect information about how our visitors use our website. This collection is anonymous. It will look at the numbers of visitors, the pages visited and how visitors are arriving on the website. To protect your privacy, we have security plug ins on the website and data CAPTCHA on the contact form to prevent spam. Mail Chimp is secured with two factor authentications.

## HOW LONG DO WE RETAIN YOUR DATA?

## WHAT RIGHTS DO YOU HAVE OVER YOUR DATA?
